2. MODEL

New current model year production HALF Ton 4X4 Pickup Trucks (Ford F-150, RAM 1500 or Equal). Reference: In-Service JEA UNITS for additional details and clarification.

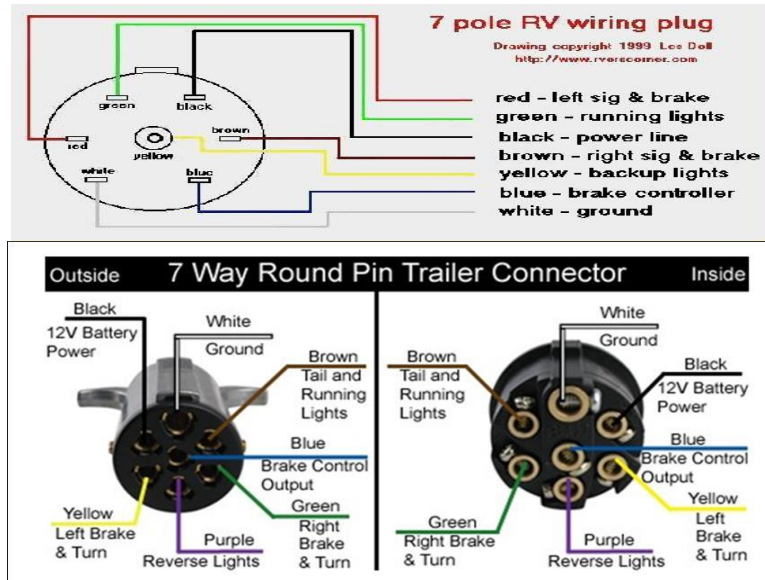

- 11.3 **All Cab / Chassis Lights:** LED ONLY.
- 11.4 4 Corner Mounted, Recessed LED Strobe Lights.
- 11.5 **DC Accessory Power Outlets:** THREE DC Power Outlets in cab for accessories with spring loaded cover (For Cell Phone Chargers & Etc.). See example below (NAPA Part Number & Picture): NAPA Part # BK 7821773 or equal. Power/Wire to the Auxiliary / Accessory Fuse BLOCK



- 11.6 **MASTER SWITCH WITH LOCKOUT/TAGOUT:** In Cab (Mitigate Dead Batteries Due To GPS, Fuel Rings & Etc.). **EXAMPLE: TR SERIES DUAL POLE MASTER DISCONNECT SWITCH (500A • DPST • IP67/IP69k • Integrated Lockout Tagout).** Mount close to battery in the engine compartment with correct type/size wiring and connections.

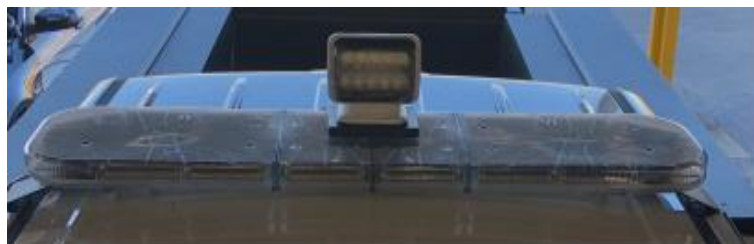

- 16.3 **Install JEA Required/Provided Safety Equipment:** Purple-K Fire Extinguisher (5 lb.), First Aid Kit and Key Safe.
- 16.4 Current **DOT** Inspection / Certification with Decal installed lower left inside corner of windshield. Include Current Date, Current Hours, Next Service Due Date and Next Service Due Hours.
- 16.5 Reflective Roadside Triangle Warning/Hazard Kit.

- 1) **ADD** Fiberglass Topper with Dual Window Mounted Utility Bins: Include Led Bin Lights, Both Bins and One LED Light mounted to the Inside/Top/Center of the Topper. One Lighted / labeled switch to operate all the Topper lights mounted in the cab.
